

YAMHILL COUNTY TRANSIT ADVISORY COMMITTEE (YCTAC)

Creation: B.O. 10-340; 09/20/2018

Membership: 5-11 members and a Board of Commissioner liaison (non-voting). Members must represent the following groups: low income; 65 or older or people with disabilities; public transportation service providers or non-profits that provide public transportation services and; Yamhill County transit users. See by-laws for additional member requirements.

By-laws: Adopted by B.O. 18-341 at the time of creation.

Term: 3 year terms staggered to expire the last day of June; initial term ending June 30, 2019. No term limits.

Quorum: For official business 6 voting members. A majority of the filled positions will constitute a quorum if there are vacancies.

Officers: Chair appointed by the Board of Commissioners, vice-chair and secretary as elected by members; except for the Chair, no member may serve more than one year in a particular office.

Meetings: Fourth Thursday quarterly (Jan/Apr/Jul/Oct), 3:00 pm in the Courthouse, Rm 32.
