

YAMHILL COUNTY TRANSIT ADVISORY COMMITTEE (YCTAC) (p. 1 of 2)

- Creation:* B.O. 18-340; 09-20-18
- Membership:* 5 - 11 members and a Board of Commissioner liaison (non-voting). Members must represent the following groups: low income; 65 or older or individuals with disabilities; public transportation service providers or non-profits that provide public transportation services and; Yamhill County transit users. See by-laws for additional member requirements.
- By-laws:* Adopted by B.O. 18-341 at the time of creation.
- Term:* 3 year terms staggered to expire the last day of June; initial term ending June 30, 2019. No term limits.
- Quorum:* For official business 6 voting members. A majority of the filled positions will constitute a quorum if there are vacancies.
- Officers:* Chair appointed by the Board of Commissioners, vice-chair and secretary as elected by members; except for the Chair, no member may serve more than one year in a particular office.
- Meetings:* Fourth Thursday quarterly (Jan/Apr/Jul/Oct), 3:00 p.m. in the Courthouse, Rm. 32.
